Activity report for 2018

General information

The objective of the chamber, as a non-profit organization, is to promote the development of trade and investments between Sweden and the EAC countries by providing a platform for business people to meet.

EAC is the acronym for the East African Community which includes the member states Burundi, Kenya, Rwanda, South Sudan, Tanzania and Uganda.

During 2018, the planning for "EAC – Business and Investment Forum 2018" in Stockholm has been ongoing, with a strong effort from SWEACC Board and the EAC embassies.

Cluster development

SWEACC started the cluster initiatives during 2016 and has had a good development during 2017 and 2018. Green City was our first cluster to be initiated and as follow-up we have established Investment and NGO clusters that have started to grow. Healthcare cluster has been on its way for two years and has now in the beginning of 2019 started to grow. We have even ICT as our strategy and will focus on an ICT cluster within the Chamber.

Cluster development is a way to create member value inside our Chamber as members can meet and get to know other members with same interests. We estimate that at least 10 new members have joined SWEACC during 2018 because of our cluster initiatives. DLA Piper, also new member during 2018, have supported us with venue place during many cluster meetings during 2018 but we need to have more venue places as most cluster meetings involve 20-40 people each time.

The board has during 2018 continued to pay interest to a loan agreement, conditionally with a shared responsibility between the attending board members, in order to save a shortfall in incoming member's fee by the end of 2017. The loan will be returned during Q2 and Q3 2019.
